PUBLIC NOTICE

This is furtherance to our Public Notice dated 10.10.2024.

CORRIGENDUM

- (1) In the public notice dated 10.10.2024, it was informed that the employees, who were in the services of the Bank between 01.09.1987 and 31.03.2010, who had ceased from the services of the Bank on account of resignation/compulsory retirement/dismissal/removal/termination before **01.04.2018** have to submit the application for pension. Whereas the date 01.04.2018 is to be replaced as **date of publication of Karnataka Gramin Bank (Employees') Pension (Amendment) Regulations, 2024 in the Official Gazette of India.**

The corrected paragraph is reproduced as under for clarity:-

It was informed to all such ex-employees made eligible vide the said amendment in pension regulations and were in the services of the Bank between 01.09.1987 and 31.03.2010 who had ceased from the services of the bank on account of resignation/ compulsory retirement/ dismissal/ removal/ termination, before the date of publication of Karnataka Gramin Bank (Employees') Pension (Amendment) Regulations, 2024 in the Official Gazette of India and also the left out cases who were eligible as per principal pension regulations and currently not drawing pension/ family pension from Bank have to submit Duly Filled Application along with necessary documents by personal visit to nearest Regional Office of Karnataka Gramin Bank.

- (2) Further, the Ex-Employees, who had exercised an option under clause (b) of sub-section (3) of section 23A of the RRB Act (who had opted for unwillingness at the time of amalgamation) shall be entitled to pension.
- (3) All the Ex-Employees/Family of Ex-Employees who are made eligible vide said amendment are requested to submit the application.

Ex-Employees and Family of Ex-employees are advised to be in readiness to refund the amount or authorise the Bank to recover the amount from the pension amount payable to them (refer amended pension regulations) in 15 days and 30 days respectively from the date of notification. It is further advised to the intended beneficiaries to regularly check the Pensioners Area >> Pension Amendment - on (<https://karnatakagraminbank.com>) for Date of Notification.
