1. Intending buyers should submit their offers in sealed covers, which has to be put in the tender box kept at Karnataka Grameena Bank, Head office, General Administration Wing, # 32, Sanganakal road, Gandhinagar, Ballari - 583103 along with the requisite MONEY DEPOSIT of ₹ 5,000/- for the vehicle by way of Demand Draft drawn in Favour of Karnataka Grameena Bank, Head office, Ballari. Kindly note that EMD is not eligible for interest. EMD in the form of cash is not accepted.
2. The last date for issuing the tender forms (offline) from office is 04:00 PM of 16.09.2026 and the offers in sealed covers will be accepted up to 05:00 PM of 16.09.2026. Offers received on or before the stipulated date and accompanied by requisite EARNEST MONEY DEPOSIT will only be considered. TENDERS WILL BE OPENED AT 03:00 PM TO 05:00 PM ON 17.09.2026 at Karnataka Grameena Bank, General Administration Wing, # 32, Sanganakal road, Gandhinagar, Ballari - 583103.
3. The EARNEST MONEY DEPOSIT will be refunded to the unsuccessful bidders. No interest shall be payable on the EMD. THE OFFER ONCE MADE SHALL BE IRREVOCABLE.
4. In case of acceptance of the offer by the Bank, the EMD shall be adjusted against the total price offered by the successful bidder subject to payment of the balance before the stipulated date.
5. The acceptance of the offer will be intimated to the successful bidder or notified on the Notice Board at the Karnataka Grameena Bank, Head Office, Ballari and such notice shall be deemed to be personal notice of information to the successful bidder and shall be binding on him.
6. The successful bidder shall pay the balance amount forthwith within 5 working days from the date of acceptance of the offer.
7. In case of failure/default and/or refusal of the bidder, whose offer has been accepted, to pay the balance on the stipulated date the EMD of ₹.5,000/- will be forfeited by the bank by way of liquidated damages and the bank shall be at liberty to sell the vehicle to any other person and in such other manner as it may deem fit.

10. Only residents of the Karnataka State are eligible for participating in this auction and no letter will be issued for obtaining NOC for transfer of vehicle to other states.
11. The Bank reserves the right to reject any offer without giving any reasons thereof. The bank shall not be responsible for any loss, damage decay, and theft or removal of parts from it or in any manner whatsoever.
12. The bank shall have the option and liberty to sell the vehicle in case of the purchaser's failure to take delivery within the stipulated period after issuing a notice to the purchaser's given address. After a period of 15 days from issue of notice the Bank shall be entitled to exercise its option to resell the vehicle.
